

Introduction

The principle of cocreation and constructive engagement have been in practice in Jigawa state prior to the introduction of Open government partnership (OGP). There exist some platforms and Technical Working Groups (TWGs) that were established with nearly equal membership between the COS and government officials with co-chairs from both sides. Platforms such as Jigawa Maternal accountability Forum and other TWGs embedded the principle of cocreation and partnership to achieve single objective.

Thus, the OGP was seamlessly and wholeheartedly embraced and accepted by all parties.



The Thematic Areas

The State Action plan has five thematic areas, they were agreed upon after series and rigorous consultations, engagement and drilldown. Initially, seven thematic areas were identified. Later reduced to five. The agreed thematic areas are in tandem with state development plan and 12point agenda of the present administration. Meaning the SAP is not a stand alone document, it is a response to overarching state development plans and serve as catalyst for achieving them.
